The escrow/closing office is authorized and directed to withhold this payment from Seller's proceeds at Closing. The provisions of this Section 1 of this Addendum shall survive Closing.

2. Additional Terms.

ALL OTHER TERMS of the REPC, including all prior addenda and counteroffers, not modified by this ADDENDUM shall remain the same. Seller Buyer shall have until : AM PM Mountain Time August 06, 2024 to accept the terms of this ADDENDUM in accordance with the provisions of Section 23 of the REPC. Unless so accepted, the offer as set forth in this ADDENDUM shall lapse.
